With the above in mind, I hereby release the TUMBLEMANIA staff to render temporary first aid to my child or children in the event of any injury or illness, and if deemed necessary by the TUMBLEMANIA staff to call our doctor and to seek medical help, including transportation by a TUMBLEMANIA staff member and or its representatives, whether paid or volunteer, to any health care facility or hospital, or the calling of an ambulance for said child should the TUMBLEMANIA staff deem this to be necessary.

We, the staff of TUMBLEMANIA recognize our obligation to make our students and their parents aware of the risks and hazards associated with the sport of gymnastics, trampoline & tumbling, cheerleading, and dance. Students may suffer injuries, possibly minor, serious, or catastrophic in nature. Gymnastics, Trampoline & Tumbling, Cheerleading, and Dance can be dangerous and can lead to injury!

Parents should make their children aware of the possibility of injury and encourage their children to follow all safety rules and coaches' instructions.

TUMBLEMANIA, its coaches and other staff members, will not accept responsibility for injuries sustained by any student during the course of gymnastics, trampoline and tumbling, dance, or cheerleading instruction, or open workouts, or in the course of any exhibition, competition, or clinic in which he or she may participate or while traveling to or from the event, including without limitation any illness or injury related to COVID-19 or any other communicable or infectious disease.

With the above in mind, and being fully aware of the risks and possibility of injury involved, I consent to have my child or children participate in the programs offered by TUMBLEMANIA. I, my executives or other representatives, waive and release all rights and claims for damages that I or my child may have against TUMBLEMANIA, whether or not caused in whole or in part by the negligence or other fault of Tumblemania, its owners, principals, agents, directors, officers, managers, employees, sponsors, contractors and engineers, whether paid, contractors, or volunteers (the "Released Parties"), and whether any such claim is based upon negligence, breach or warranty or contract or any other legal theory. I also agree to indemnify and hold the TUMBLEMANIA and the Released Parties harmless from all losses, liabilities, damages, costs or expenses (including but not limited to reasonable attorney's fees and other litigation costs and expenses) incurred by any of the Released Parties as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Released Parties to recover any losses, liabilities, costs, damages or expenses which arise during or result from my attendance and presence at Tumblemania and/or my participation in the Activity, regardless of whether or not caused in whole or in part by the negligence or other fault of the Released Parties. This Agreement is governed by the applicable law of Florida. If any part of this Agreement is determined to be unenforceable, all other parts shall be given full force effect. I further agree to indemnify and compensate for any damages that I may cause during the Activity to any property of Tumblemania and the Released Parties.

I also affirm that I now have and will continue to provide proper hospitalization, health, and accident insurance coverage which I consider adequate for both my child's protection and my own protection.

I also understand that it is the parents' responsibility to warn the child about the dangers of gymnastics and injury. The parent should warn the child according to what the parent feels is appropriate. TUMBLEMANIA will only warn the child through "Safety Messages" and our teaching style and progressions.

I affirm that I am the Parent or Legal Guardian of the Student identified above, that I am at least 18 years of age, and that I have freely signed this document.
